All NCA exams in 2023 will have a time limitation of 3 hours.

NCA exams are scheduled during specified times either in the morning or in the afternoon, depending on the date and the exam subject. When referring to the exam schedules, please select a date and time that is most convenient for you.

- * Morning exams will start between 07:00 and 10:00 hrs (Eastern time)
- * Afternoon exams will start between 14:00 and 17:00 hrs (Eastern time)
- * Exams offered both in the morning and the afternoon will follow the same times as above.
- * Midday exams will start between 11:00 and 14:00 hrs (Eastern time)

You will be assigned a start time within the timeframe you specify when you register for the exam. Your exam start time will be posted in the NCA Portal once it has been assigned.

If you wish to request a change in the date or start time, please contact MonitorEDU directly at schedule@monitoredu.com. Change requests are subject to availability. Please note, however, that all start times will be within the set time blocks, and time slots will not be available outside of those blocks. (e.g. if an exam is scheduled only for the morning you will not be given an afternoon start time. You will be required to change dates if you need to write in the afternoon).

Cancellations are only accepted in the NCA portal before Midnight (Eastern) of the day before the exam.
