



## 2024 NCA Exam Schedule

Please note that both registration dates and exam dates in this schedule are subject to change. Please refer to the **Advisories** section of our website for updates.

All NCA exams have a time limitation of 3 hours.

NCA exams are scheduled during specified times either in the morning or in the afternoon, depending on the date and the exam subject.

- \* Morning exams will start between 07:00 and 10:00 hrs (Eastern time)
- \* Afternoon exams will start between 14:00 and 17:00 hrs (Eastern time)
- \* Midday exams will start between 11:00 and 14:00 hrs (Eastern time)

We will make best efforts to assign a start time within the timeframe you specify when you register for the exam. Your exam start time will be posted in the NCA Portal once it has been assigned.

Change requests are subject to availability. Please note, however, that all start times will be within the set time blocks, and time slots will not be available outside of those blocks. Cancellations are only accepted in the NCA portal before Midnight (Eastern) of the day before the exam.
