

Examination Schedule for 2025

Please note that both registration dates and exam dates in this schedule are subject to change. Please refer to the [Advisories](#) section of our website for updates.

All NCA exams have a time limitation of 3 hours.

NCA exams are scheduled during specified times either in the morning or in the afternoon, depending on the date and the exam subject.

- * Morning exams will start between 07:00 and 10:00 hrs (Eastern time)
- * Afternoon exams will start between 14:00 and 17:00 hrs (Eastern time)
- * Midday exams will start between 11:00 and 14:00 hrs (Eastern time)

We will make best efforts to assign a start time within the timeframe you specify when you register for the exam. Your exam start time will be posted in the NCA Portal once it has been assigned.

If you wish to request a change in the date or start time **within the same exam session**, you may do so by filling out the MonitorEDU form [here](#). If you wish to take your exam at a future date **not within the same session**, please cancel it in the NCA portal before midnight of the day before you are scheduled to write the exam. Simply schedule for the next session once registration opens.

Change requests are subject to availability. Please note, however, that all start times will be within the set time blocks, and time slots will not be available outside of those blocks. (e.g. if an exam is scheduled only for the morning you will not be given an afternoon start time. You will be required to change dates if you need to write in the afternoon).

Cancellations are only accepted in the NCA portal before Midnight (Eastern) of the day before you are scheduled to write the exam.
